Sweepstakes Official Rules

Sweepstakes begins at 12:01 a.m. Eastern Standard Time (EST) on August 1, 2021 and ends at 11:59 p.m. EST on February 28, 2022.

A. To Enter:

Entrants will register to become an Amway customer and opt in to the AmPerks™ Program. One entry per email address.

B. (70) Winners:

Each month Sponsor will select ten (10) winners to receive 1000 (U.S. and Canada) 50,000 (Dominican Republic) AmPerks™ points. Estimated Retail Value is \$10 (U.S. and Canada) and RD\$500 (Dominican Republic).

Total approximate retail value of the entire Sweepstakes is US \$700.00/RD\$35,000.

Odds of winning depend on the number of eligible entries received. Prizes are non-refundable and non-redeemable. All other expenses not specified are the sole responsibility of the winner. All taxes are the sole responsibility of the winner. C. Winner Selection:

Winner will be selected randomly by using a computer-generated application tool on or about the 15th of each month from among all eligible entries received during the Entry Period. Determination of winner will be the responsibility of Sponsors, whose decision will be final and binding in all matters related to this Sweepstakes.

Winner will be notified by email and/or phone. If a winner cannot be notified within five (5) business days, does not meet eligibility, or does not comply with Sweepstakes rules, the prize will be forfeited and awarded to an alternate winner. In the event prize winner is unable to redeem the prize due to reasons beyond their control no compensation or substitutions will be provided.
